

## **INFORMATION ABOUT YOUR NEW SERVICES**

Dear Glendale Customer:

On behalf of the entire Waste Resources (WR) team, welcome to the WR family! WR begins its services for the rest of the City of Glendale's Zone C on February 1, 2022 under the terms of the new Franchise Agreement, and we look forward to providing you with great service that turns Today's Waste into Tomorrow's Resource. Even if your containers have not been exchanged yet, WR is collecting your material as of February 1, 2022.

We have received service information from your current service provider, so your services and service days will not change for now. If we have not reached out to you yet, we will be contacting you in the near future to review service options and confirm, modify, or update account information. In addition, we will be preparing for the following <u>mandatory</u> services by March 31, 2022, if not already in place:

- BLUE-lid for dry recyclables;
- **GREEN-lid** for organics; and
- BLACK-lid for trash (non-organic and non-recyclable items).

These mandatory services are required by State law to increase waste diversion and reduce landfill waste and greenhouse gas emissions. There are exemptions available for accounts that do not meet certain criteria. Contact <u>franchise@glendaleca.gov</u> for further information.

As part of the new Franchise system, services available include:

- Bulky Item and E-Waste Collection<sup>1</sup> 1<sup>st</sup> 4 pickups per year per account are free;
- Temporary Roll-Off and Bin (Dumpster) Service for clean-up and construction projects;
- Scout and roll-out service;
- Horse accounts;
- Locking lids;
- Bin steam cleaning free 1x per year;
- Graffiti Removal free 1x per year;
- Cart/Bin Replacement free 1x per year;

<sup>&</sup>lt;sup>1</sup> Commercial and multi-family properties can receive up to 4 free collections of bulky items per year. The account holder is responsible for ensuring that tenants are informed of the process for scheduling collection of bulky items, as fees may be charged to the account holder for additional collection services. Items left on the curb without property owner notification is considered illegal dumping and may be subject to fines.

- Carts in 64 or 96 gallon capacities;
- Bins in 1, 1.5, 2, 3, 4, 5, or 6 cubic yard capacities;
- Compactors and roll-off boxes in 10-50 cubic yard capacities;
- Recycling service at half the equivalent trash rate; and
- Edible food Recovery opportunities<sup>2</sup> (through new City program).

Your new containers will have decals detailing what goes in which container. We can also provide you with posters for use inside your facility to remind your staff/residents of good recycling habits, which are crucial to the success of expanding the City's state-mandated recycling goals.
