IMPORTANT REMINDER FOR PROPERTY OWNERS & MANAGERS: Waste, Recycling, Organics, and Bulky Item Collection Services

Since April 1, 2022, all multi-family complexes are required to subscribe to recycling and mixed organics collection services¹, including separating ALL landscaping waste, food scraps, and food-soiled paper (100% fiber-based).

As your provider of waste collection services, Waste Resources is here to assist you and your tenants in managing waste generated on your property. Your participation is critical to assist the City of Glendale in reducing landfill waste and greenhouse gas emissions.

Waste Resources is here to support you and your tenants with this program and will provide training and resources to help you succeed. We are available to assist in educating your staff and tenants by answering any questions, performing site visits, or providing printed outreach materials. Under State Law SB 1383 and/or City of Glendale requirements, you are required to:

- **Subscribe** to trash, recycling, and organics recycling collection services (see attached flyer).
- **Educate** employees and tenants on how to properly sort waste, recycling, and organics into the correct containers; and educate new tenants within 14 days of occupation of the premises.
- **Ensure** any bulky items placed in front of your property are scheduled to be promptly removed.



Keep copies of the enclosed flyer in all places where trash is collected throughout your complex to remind everyone on proper container usage.
